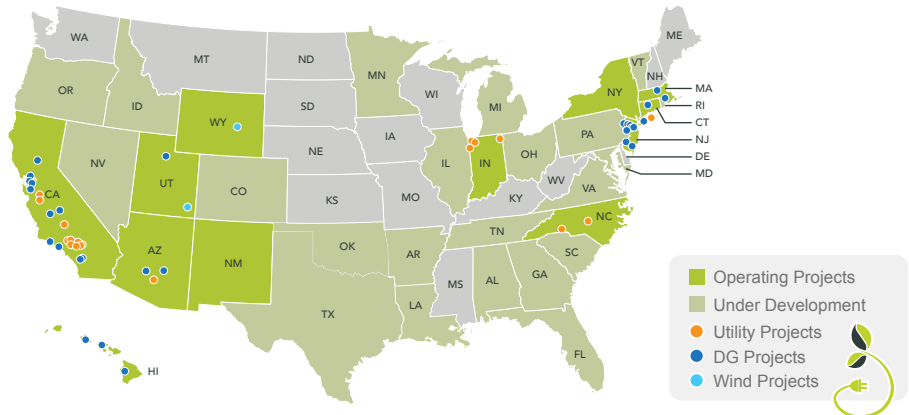

OUR HISTORY

2012

- First tax equity partner, PNC Bank.
